A 50 years celebration of successful and innovative document management

2024 marks Plockmatic's half-century of innovation and success. Since its establishment in 1974, Plockmatic has continually evolved, introducing numerous ground breaking technological advancements and solutions. With a combination of organic growth and strategic acquisitions, Plockmatic has established itself as a leader in document finishing.

Unlike many other start-ups that often begin their operations in a garage, founder Terje Söderberg started his journey in a laundry room. Terje had acquired a patent for a sorting machine and, together with two partners, began building prototypes in the laundry room.

With their strong expertise in electronics, they soon developed a finished product that they began to sell. Shortly thereafter, the company, then called Guternik, moved into a converted grocery store that was transformed into an office. As sales accelerated, the company expanded its range with new products such as staplers, folding machines, and various types of picking machines. The business then moved to even larger premises in Stockholm and changed its name to Plockmatic.

The company continued to prosper, and it then had 30 employees. However, since Sweden is a relatively small market, it was decided in 1976 to participate in the CeBIT in Hannover, a major fair focusing on technological products and services, including office equipment. This became an important milestone for Plockmatic, where they came into contact with competitors, printer suppliers, and agents and distributors. This led to Plockmatic beginning to sell its products in the other Nordic countries, England, France, and even outside the EU, increasing their international presence. Plockmatic is best known for its booklet makers. In the early 1980s, the company began developing its first booklet maker.

In 1998, Jan Marstorp was recruited to Plockmatic International as production director, after Electrolux where he had served from 1987 as product manager and then as product line manager. At the time of Jan's arrival Plockmatic cooperated with the state own company Samhall for assembly, an investigation in to changing the strategy on assembly and logistics was looked at and the decision was taken in 2000 to open up our own assembly operation in Riga, Latvia. A strategic move that required skilled management of both production and

logistics processes. Jan took on this challenge with notable skill, leading to noticeable improvements in quality and production processes. His ability to effectively lead and develop the company made him highly respected within the company, and he soon took on expanded responsibilities as development manager.

The company, which was 30% owned by the investment company 3i, wanted to bring in more capital to develop more products together with the print companies and also to acquire other companies. It became clear that Grimaldi Industri AB would buy the company, and in connection with the acquisition, Terje chose to leave and Jan stepped in as CEO.

Growth through acquisitions and collaborations

Since Jan took over as CEO, the company has continued to expand significantly through corporate acquisitions and the development of collaborations for inline products.

Through these acquisitions and partnerships with the largest print suppliers, Plockmatic has positioned itself as a world leader in document finishing and can now offer a complete range of products and services for this sector.

USA

In 2006, Plockmatic established a sales and support office in the USA primarily to support major customer Xerox. In 2010, a new sales and support office with a demo center and its own warehouse was opened to offer better support to the print companies, but also to sell Morgana's offline offering through US resellers. In recent years, the USA has experienced significant growth and is now the largest market for Plockmatic, accounting for 50% of turnover.

2024

Plockmatic is proudly celebrating its 50th anniversary, after a successful 2023 where the company not only reached but exceeded its financial goals and achieved a turnover of 740 MSEK. The forecasts for 2024 indicate that the company will once again break records. During the year, the company will celebrate together with partners at DRUPA and Printing United and with the opening of a new factory in Riga, Latvia.

In addition to the anniversary celebrations, 2024 was an eventful year for Plockmatic. The year began with new ownership where Accent Equity became the main owner at the turn of the year. During the year, the launch of 29 new products was planned, most of which will be showcased at DRUPA and include both inline and offline solutions. In the spring, production in Riga was moved to a completely newly built production facility of 10,000 square meters.

A message from Jan Marstorp

The business has evolved over 50 years starting with sales in Sweden through direct and dealers sales and moving into Europe as we started to attend Cebit. Cebit was a very large and important fair to meet and engage with existing and new partners. We all remember the finishing hall number1 that was exclusive for our industry – and only used once per year!

Sales through dealers and distributors was the only route to market, and our product portfolio consisted initially of collators and was later enhanced with booklet makers.

By the mid to late 80's Xerox was the first print partner that we started to cooperate with. The first Xerox products was a corner staple manual product called RX920 - and only sold in Sweden.

It was during Cebit that the concept of connecting the offline booklet maker PL80 to a printer was born - of course this was possible, and the ASF92 connected to the Xerox 1020 was created. Xerox – being the Document Company with its expertise in TQM did a great job in developing Plockmatic from a very entrepreneur organisation to a TQM certified company with a strong entrepreneur mind set. The business with Xerox developed very well during the 90's – 35 years ago!

We then meet Ricoh late in the late 90's. They need a booklet maker, so we sent a team to Japan together with a booklet maker : PL75-2, needless to say our team onsite in Japan succeeded to connect the two devices by direct cables into printers PCB, and we had a simple communication, and so began a good relationship with another major print manufacturer.

However, we needed to be ready to manufacture. The Xerox TQM certification gave Ricoh Quality organization enough confidence to launch the first inline booklet maker solution within 9 months. This was a great achievement and the launch of Ricoh Aficio and SR85 went well. This has lead to a successful cooperation since then, today we have a business together that includes several platforms of booklet makers and pre as well as post paper handling equipment's.





After failed launch directly with Océ in the mid 90's, we meet with Océ appointed finishing partner – SDD. They were looking for an inline booklet maker solution and Plockmatic had it - a set batched machine that was in process to be re-engineered to a sheet-by-sheet machine. Océ and SDD did a great job of promoting and selling the system – the re-engineering became stressful when we shipped out 100 of machines – our relationship with SDD became very tight and intense – and we have developed a great cooperation since then! Canon bought Océ and our relationship became wider. Today we have a business together, both via SDD as well direct with Canon – these two includes several platforms of booklet makers, post finishing – and at DRUPA we launched a feeder for long sheets.

In January 2013 we made the big move – acquiring Morgana with a very strong offline distribution channel and products – including the well established creaser and folder products. Many of our exiting dealers came with Morgana, and we did get a much greater reach and sales of our offline products. Morgana became the offline channel and inherited all offline products from Plockmatic!

In 2013 we established our own sales companies: PDF AB in Sweden, PDF AS Norway and PDF Baltic in Riga. Welcome Fredrik, Tommy and Toms, this provided us with an even tighter connection to the market including end customers!

Our relationship with Sharp and Konica Minolta started in 2013. Or successful 35/50 booklet maker platform including square fold technology led us to start cooperating with Sharp. Konica Minolta are selling two of our booklet platforms as well as feeders and in process of developing cooperation's on additional products.

In 2016 we acquired KGS and added new colleagues in Italy to develop a wide range of binders, and patent the technology of perfect binding using PUR glue. The Perfect Binders has been primarily sold through our dealers, and at DRUPA we launched the next generation – also for inline!

And then came the mighty PowerSquare. In 2018 we acquired the Watkiss business which gave us two very strong products, the PSQ224 capable of producing a 224 page finished book with our signature square fold finish, and the PSQ160 which offers the large format or A4 landscape format. With the PowerSquare – we added a new type of end customers, and in addition we also added new colleagues in UK. At DRUPA we introduced our next generation that is replacing both PSQ224 as well as PSQ160!

By now we have a finishing solution for many applications, and then In 2017 / 2018 we met with Tony Michiels from Argos. The Argos LED coating technology complemented our applications very well and a strong cooperation was formed. With the addition of these coaters, we have had the opportunity to meet with high end customers in the professional segments. We are learning a lot from these customers.

In 2022 we move into packaging & labelling by acquiring Intec Printing solutions. With Intec, we are entering a very new segment of the market for digital print. Intec added several new dealers worldwide, and are a great contribution to our Group. We introduced a wide range of enhanced Colorcut and ColorFlare products at DRUPA – the range is rapidly expanding to meet the demands of this growing market.

DRUPA 2024 – we are launching three new business cooperations. FujiFilm - former partner with Xerox that today is a leading provider of a large range of printers. Kyocera – expansive experience in printing and our cooperations starts around their ink jet printers. Riso – a well established print providers with unique price performance on ink jet technology.

Salvatore has been a great owner; he labels himself as a crazy entrepreneur, he has really understood the value of meeting customers' expectations, supported our business in all areas, allowed us to continuously invest in our product portfolio, made acquisitions to further support our value proposition as well as developing our own organisation.

On January 22nd 2024, Salvatore sold off the majority shares of Plockmatic to Accent Equity – a Swedish investment company. "Accent Equity is one of the buy-out investment pioneers in the Nordic region. Based on teamwork and unmatched deal experience from 90+ platform investments, with a consistent investment focus since 1994, and over 200 add-on investments". The combination of Salvatore Grimaldi and Accent Equity – Plockmatic Group has two financially strong professional owners that I am looking forward to further grow our value proposition in the years to come.

Plockmatic seals the deal to acquire Morgana Systems

Plockmatic has bought Morgana Systems, the British manufacturer of digitally biased finishing systems. The deal ends a search for a suitable home for the business started by Paul Garratt and Andrew

Webster 35 years ago and allows them to pass the business to an ideal owner.

Both companies are in the business of producing finishing technology for digital print. But while Morgana has produced standalone units starting with a creaser and working up to the DocuMaster Pro collating digital bookletmaker, the Swedish company has focused on supplying engine manufacturers with inline technology. Its folders and bookletmakers are integral to printers built by Xerox, Canon, Océ and others. Plockmatic also has a range of mailing systems which fills a gap that Morgana has had.

Morgana has always been committed to manufacturing in the UK, assembling wiring looms and writing software as well as putting together the machines together in a purpose built factory in Milton Keynes. The company had started with a range of folders designed for small format and inplant use, making the breakthrough when realising that output from digital presses needed creasing if it was to be folded without cracking.

The company made good use of the opportunities in digital printing, helping to expand the company's sales through exports to stand at £14.4 million in 2011, generating a pre-tax profit of £1.6 million.

2016 Plockmatic acquires KGS

Three years ago Swedish company Plockmatic acquired Milton Keynes based Morgana. Now it has bought the manufacturer of the perfect binders that Morgana sells. Plockmatic has pledged to expand

production of PUR perfect binders following the acquisition of Italian manufacturer KGS.

It sells these as the Digibook series as 150, 200 and 450 cycles an hour machines using PUR adhesives from a closed tank design which avoids glue wastage.

Ray Hillhouse, Morgana VP sales and marketing, says: "We have been selling the KGS manufactured products for several years now and have seen the market grow significantly over that time. "We have taken the total production from the factory for the last two years, selling PUR products throughout the world, and now need to increase production to meet the continually growing demand from new and expanding markets."

"Owning the company will allow our expertise in supply chain and production to help KGS grow, while simultaneously reducing costs. Savings will be directly passed on to our customers and dealers."

The entry level DigiBook 150 copes with a spine from 1mm to 50mm and spine length from 110mm to 380mm. The top of the range DigiBook 450 is still a single clamp binder, extending the spine length to a maximum of 450mm and operating at 450 cycles an hour.

Plockmatic Group acquire Watkiss Automation

The Stockholm, Sweden-headquartered group completed the acquisition of Sandy, Bedfordshirebased Watkiss on Monday (10 September).

The move follows Plockmatic's 2013 acquisition of Milton Keynes-based Morgana, which took the company into the offline bookletmaking market, and its 2016 purchase of Italian bindery kit manufacturer KGS Bindery.

Plockmatic said its acquisition of Watkiss, which develops and manufactures high-end bookletmaking systems, extends the group's range into that market segment. According to its most recent accounts, the business had sales of £6.9m.

Watkiss machines are sold by OEM partners worldwide under the PowerSquare brand. The business also sells offline bookletmaking systems through a worldwide network of dealers, as well as a range of finishing products through its direct sales team in the UK.

The firm's recent launches include the PowerSquare PSQ160, which operates both offline and inline and supports the landscape booklet format, and the PowerSquare 160-WH, which is targeted at the A4 landscape market.

Watkiss, which was previously owned by the Watkiss family, will now become a wholly owned subsidiary of Plockmatic International and will be part of the Plockmatic Group.

Plockmatic acquires Intec Printing Solutions

Ray Hillhouse, VP sales & marketing for Plockmatic's Offline Business Unit, confirms the deal fast-tracks the group's ambitions into offering digital flatbed cutting tables.

"To actually go out and source one and find the right software to drive it and get all that running in a short space of time would have been a struggle, so we started looking at potential acquisitions and Intec came on our radar," he said.

As a result of the deal, which completed on 8 July, Intec joins a Swedish group that also includes fellow UK post-press manufacturers Morgana and Watkiss.

Intec's portfolio also includes the ColorFlare range of embellishment laminator/foilers. As well as consumables, the range consists of Desktop ColorFlare CF350 and standalone ColorFlare CF1200 professional.

"Intec are well known in the industry for providing quality products at competitive prices," said Plockmatic CEO Jan Marstorp.

"These systems are ideal for small to medium sized print-based operations that need to provide professionally cut and finished promotional display boards, boxes, labels and more. This is a sector of the market that has grown rapidly in recent years, and one that Plockmatic is keen to further explore and expand."

Intec has 17-staff at its UK headquarters in Poole, and a two-person US dealer-support operation based in Florida.


